AND




1. PREAMBLE

WHEREAS ISKCON (International Society for Krishna Consciousness) as part of its Student development activities desires to collaborate with SRCPS under Department of Student Welfare for promoting special education in accordance with timeless Value & Wisdom to enhance personality & attitude (herein after referred to as "ISKCON (International Society for Krishna Consciousness) Courses/Programs") among students undergoing education in the university for all branches and all courses, so as to help them develop a healthy mindset & balanced lifestyle which is much needed by the modern youth of today.


NOW THEREFORE in consideration of the foregoing & mutual covenants and promises contained herein the Parties are agree as follows

- (c). Arrangement of Facilitators, Materials (wherever applicable)
- (d). Issue ISKCON (International Society for Krishna Consciousness) certificate to Students (wherever applicable)
- (e). Compiling student feedback & submitting to SRCPS.
- (f). Submitting regular reports of activities done for students to SRCPS.
- (g). ISKCON (International Society for Krishna Consciousness) enlists its activities and methodologies to enhance skill development and boost students' morale.





The Student Activities provide programs and services to students in the following manner:

- (c). To arrange & provide required infrastructure & facilities like:

 - (2). Dedicated notice board / space in common notice board in college & hostel premises
 - (3) Permission for using the classroom.
 - (4) Permission to use auditorium as per availability
 - (5) Dedicated LCD Projector
 - (6) Locker / Small room(Counseling Room) to store ISKCON (International Society for Krishna Consciousness) paraphernalia /course material & other documents
 - (7) Books and other Reading materials in soft/Hard copy in sufficient quantities
 - (8) Audio/Video equipments such as Mics and Speakers in seminars

TERM/DURATION OF MOU:



LIMITATION OF LIABILITY:





In the event of the occurrence of such dispute, either Party may, by written notice to other Party, have such dispute referred jointly to the authorized representatives of the Parties, or their successors or counterparts, for resolution by good faith negotiations within 15 days after such notice is received in respect of such dispute.
